**RE: COMPLAINT AGAINST CORRUPTION AND ABUSE OF OFFICE  
BY THE DIRECTOR AND ACADEMIC REGISTRAR LAW  
DEVELOPMENT CENTER**

1. The director (Mr. Fank Nigel Othembi) and the academic Registrar (Mr. Turyahikayo Evaristo) sometimes aid of other staff members of the Law Development Center have been collecting money in forged failures of students this was at its highest in 2016 to 2018, where a number of students marks are exchanged upon payment of huge sums of money ranging from 1million to 20million shillings done depending on subjects failed and the score to be exchanged. This can be evidenced by the scripts and recorded marks in their computer system and results register books and the quality of work in different answer scripts vis a vis the mark given.
2. The above mentioned officers further use their relationship with female students to sneak them on to list of those who passed the courses and graduation lists. This is evidenced by the lists of students who pass which vary with those on graduation lists, it always includes names that didn't appeal the mark or if they appealed their mark miraculously rose from the smallest to passmark yet those missing a mark can't raise the passmark, the appeal window is the most used to mint hundreds of millions by the said officers as the desparacy is too high by students to get on to the graduation list/book.



3. The director takes it a notch high that he used the same desparecy to sexually exploit female students to get them to the graduation list/book.
4. The above said desparecy is caused by the high repeating fees where a students who was paying only 4.5 million for 15 subjects has to part way with about 10 million to repeat less than 8 of the same subjects.
5. Deliberate errors are made to get money from victims missing on graduation lists for such errors or replace their names with other students who have capacity to pay the desired money to purchase a slot in the graduation positions.
6. They designed rules of repeating in a way that everyone would raise the money they ask for to be able to avoid the repeating terms, this has left poor students and those who believe morals and virtues stuck with the crockade system.
7. When gov't in its wisdom to curb the vice of misuse of monies collected from supplementary exams and tuition opted to call for money to collected by URA, Mr. Fank Nigel Othembi LDC Director and Academic registrar begun a policy of forcing students to subscribe to Almini Association which is purely private and privately managed, before they finish studies. This wasn't the case before URA took up the collection of tuition and other fees, almini fees was actually crated as an alternative to make money from students since there was no money left for these officers to steal. This association has the director (Mr. Fank Nigel Othembi) as a leader of its committee and signatory to the account, which exhibits gross misuse of office and conflict of interest.



8. The said almini fees is swindled by the Director who shares with the academic registrar who helps him on making sure every students pays this money to a private body which they don't even qualify to be members given their status it requires.
9. The director further deals with private lawyers who charge fees to either defend matters he should have settled given his knowledge as a lawyer and his staff, he even opens up cases that are completely untenable at law to only make money in instruction fees which he shared with the lawyers that he individually hires or used his influence to have them get instructions( a good audit various cases against LDC that in court can ably reveal these, some of them can't even be lodged by a lay person without advise.
10. The said officers release results before marking some students(as per now a number of students don't have resiltis for many subjects ranging from research paper to clerkship yet graduation is week three weeks away) this has been taken to another level where they graduate students without mark, majority of these were June 2019 where students who didn't have clerkship marks and others were on graduation lists and books and indeed graduated, these are some of the miracles in church testimonies around town.
11. This has left LDC with the biggest number of cases in court since in its history since if was found close to half a century many ago( LDC has more than 50 cases and applications in courts of law in Uganda) many of these are for purposes of making money a scheme that the director(frnk Nigel Othembi uses to make money with his appointed private lawyers) he never allows the LDC legal team do anything or take its advice or even be the one to defend or institute the cases since this would deny him the



money making opportunity through possible amicable settlements and money for instructions that he shares with external lawyers.

One wonders why the alumni fees only came into place when URA came up with a policy to be in charge of monies collected.

Am through examination forensic audit will reveal all the evidence

A through life style audit of the Director and Academic Registrar will also reveal the said acts given the known salaries and their expenses, during their luxurious travels to international events like world cup and other international world first class games.
