The Constitution of the republic of Uganda under Article 20, stateth that "fundamental rights and freedoms of the individuals are inherent and not granted by the state or anyone."

The same provision of the Constitution further stateth and readeth that "the rights and freedoms of the individual enshrined in the chapter shall be respected, upheld and promoted by all organs and agencies of government and all persons."

Further still, under the said Chapter, the freedom of Association is therein established, ".....which shall include the freedom to form and join associations or unions and political and other civic organizations like the National Unity Platform."

The particular right and freedom to associations, is further preserved and protected by Article 99 of the Makerere University Students Guild Constitution, which dictates that "subject to this constitution, and other laws, any member of the Makerere students Guild shall have the right to initiate any club, or institutions with the approval of the G.R.C and Dean of students."

Important still, it is upon the parties coming into Association that there upon decide in concert as per the quorum required by their specific number of constitution, the way and format through which they deliver the associations aims and objectives as envisioned by the founders.

Unfortunately, the National Unity Platform Mak Chapter, lacks a constitution, which I personally participated in the process and other members in drafting that is at the National Executive Committee Level undergoing review for approval as per the party policies. However, this does not create a lee way through which the preserved rights and freedoms of an individual should be violated. As per this case, it is upon the discretion of the NUP Mak Chapter, Executive Committee members as confirmed by your later of 12 June 2022 pertaining the Chapter governance with guidance from the Elders forum.

The currently constituted delegates committee is illegal, unreasonable and unconstitutional.



- 1. Undermines the freedom of association of the Chapter members.
- Speaker dictated for the Committee on voting for the vetting committee members with no conclusive debate on the matter.
- 3. None members to the Executive Committee participated in the voting process which is illegal.
- 4. Composition of the vetting committee which ideally should consist of
 - 1. President
 - 2. Secretary General
 - 3. speaker
 - 4. Legal advisor
 - 5. Mobilization Secretary
 - 6. Chief whip
 - 7. Organizing secretary
 - 8. Publicity
 - 9. Head of Institutions

Was undermined and contrary to the current one which was imposed on the chapter by the Elders Forum, coercion and duress by the speaker and other members.

When this process was criticized, the rights of various executive members have been curtailed and chained at the cost of the speaker and none members of the executive committee.

Such illegal and unreasonable acts, not only create a lacuna in the total adherence of the NUP Mak Chapter with the Supreme Law of the land and other National and international laws, but also present the party structure as an oppressor and a dictator, thus violation of legal instruments and principles of Natural Justice as to the effect that Justice must not only be said to be done but also seen to be done.

Important still, such acts encourage divisions among party members and demoralize them at the same time.

I pray that this process is reconsidered to the right full procedure.

RE: RESIGNATION AS LEGAL ADVISOR

In my legal opinion dated 19th June 2022, I constitutionally performed my obligation as the profound legal advisor of the Mak NUP chapter. In the afore mentioned opinion, I cite the illegalities that curtailed and situated the establishment of the vetting committee from the executive.

Further still, more illegalities have been committed. Worth noting is that the speaker chaired the meeting in which the vetting committee was selected yet this is had to be done by the chairperson. The said committee illegally selected members to which some never turned up or vetting.

The process excluded members on allegations of political affiliations such as sisi wenyewe even when this could not be proven beyond reasonable doubt. Similarly, some members were selected on grounds of tribal affiliation while others eliminated on religious lines like the moslem community.

According to the responsibility accorded to me, I find the proceedings of the executive undermining democracy and the rule of law.

Due to such inconsistences, I hereby resign from my position as legal advisor.

RE: APPEAL FOR FAIRNESS AND IMPARTIALITY FOLLOWING THE WAY THE NUP DELEGATES WERE FORMED.

Reference is made to the vetting process that happened on 20th June 2022 following call for applications for the same by the interim general secretary to the NATIONAL UNITY PLATFORM MAKERERE UNIVERSITY CHAPTER.

I tendered in my application following to the delegates conference for the Kabanyolo hostels when the advertisement for the same came out. The list detailing the applicants was later released and my name had been omitted. I was never informed of the vetting but nonetheless attended after consulting senior members of the chapter, providing proof of application. I must note that many people whose names were omitted on the list and somehow got the information also presented the proof and they were vetted. Some of these became delegates. The other Kabanyolo hostels applicants never attended the vetting. One was sick and the other was engaged by academic activities at Kabanyolo but when the list of delegates was released, I had been thrown and my colleagues considered. When I enquired from them why they didn't go for vetting, they said, "mr OGUTTU called us and told us we were unopposed and therefore don't need to appear for vetting". On the vetting venue however, some of the applicants that were unopposed appeared and I wondered why it was a different case for my colleagues.

The process therefore was marred with irregularities, a lack of fairness and impartiality and complete denial of effective communication. Its clear that injustice was done to me and many more applicants who were completely eliminated from the list and as such therefore seek your indulgence before the process of primaries kick starts.



RE: DISTANCING FROM THE NUP MAK CHAPTER ACTIVITIES.

Following the vetting for the delegates that took place on 20th June 2022 in response to the call of application by the general secretary, a number of issues have been cited that compromise the core values and principles of the party.

Whereas the LUMBOX SOLIDARITY fronted to victory two consecutive party guild presidents, our efforts towards the glory of the party in Makerere University seem to have not been recognized in reference to the recent chapter activities. Whereas it may not matter, Lumumba hall has only one slot on the interim executive, the deputy general secretary and yet he is not a resident of the hall as he now resides in Galloway house. Lumumba hall has out of the possible 63 delegates brought only five, with four of these being medicine students. Also worth noting is the fact that on the vetting panel for the delegates, there was no one from the mighty Lumumba empire this therefore compromises inclusiveness, one of the core values of the party.

Many applicants from the mighty empire were castigated on allegations that were based on propaganda and the status quo of the hall. It was wrong of the panel to conclude that all lumumbist are pro NRM and the famous "SISI WENYEWE" just because the Lumumba candidate is the NRM flag bearer. "mr. Kateregga Julius, one of the panelists is also quoted as saying Lumumba is now a den of the NRM", justifying his orchestrated verbal attacks on all lumumba applicants. We are also left in a maze when one of the delegates makes it through and yet he didn't attend the vetting. This justifies the popular word in the empire insinuating pre-determined delegates for this hall and the entire university.

Following these and many irregularities that graced this process and the humiliation with which Lumumba Empire has been slapped thus far, the LUMBOX NUP BLOC hereby withdraws from any party activities within the university.
