## 6. Supplementary examinations for failed subjects

A student with a supplementary examination may, upon application and payment of a supplementary examination fee, undertake the same at his or her respective campus of registration as follows:

A students who sits supplementary examinations in Category B and C subjects ONLY will have results processed in time for a qualifying students to graduate with his or her colleagues of Academic Year 2022/23. A students with suppementary examinations in Category A subjects will sit examinations with the students of AY 2023/24. PLEASE NOTE THAT UNDER LDC'S REVISED CURRICULUM THERE ARE NO CATEGORY B AND CATEGORY C SUBJECTS EFFECTIVE AY 2023/24. STUDENTS REPEATING CATEGORY B AND CATEGORY C SUBJECTS WITH STUDENTS OF AY 2023/24 SHALL SIT THEIR FINAL EXAMINATIONS IN ACCORDANCE WITH THE ABOVE TIME-TABLE.

The Academic Registrar shall issue detailed instructions regarding all examinations

#### 7. Verification and Appeals

A student who qualifies for verification and appeal as provided for by the Rules Governing the Bar Course 2020 may exercise his or her right to verification and appeal. A student who applies for verification without being entitled to the same under the Rules shall have their application REJECTED summarily and any fee paid forfeited. DO NOT APPLY FOR VERIFICATION/APPEAL IF YOU HAVE NO RIGHT TO THE SAME.

#### 8. Special examinations and administrative action

Some students did not undertake all assessments. A student who missed an examination or other assessment for good cause (e.g. illness, finances, incapacity e.t.c) should write a formal letter to the Academic Registrar requesting to be allowed by the Board of Examiners to sit a special examination or other assessment missed. Deliver in hard copy to ROOM 1.2 LDC Kampala Campus.

## 9. Administrative action

A student indicated as having missed an examination or assessment who disputes the same or who has any information or query or complaint regarding his or her results and requesting administrative action by the Academic Registrar may submit a request using the email address **academicregistrar@ldc.ac.ug** 

- The Academic Registrar will acknowledge receipt of your email. You do not need to take any further action. Do not come physically to LDC to follow up your complaint or query.
- Once action has been taken on your query or complaint any changes will be uploaded on AIMS.
- After 14 days the Academic Registrar will communicate on any unresolved gueries or complaints.
- DO NOT SUBMIT MULTIPLE CORRESPONDENCES IN RELATION TO THE SAME QUERY.

#### 10. Repeating the Bar Course

A student who has failed the Bar Course on account of failing 3 or more Category A subjects may apply to repeat the Bar Course in AY 2024/25 or other subsequent academic year.

## 11. Repeating failed subject(s)

A student who has failed a subject or subjects following sitting supplementary examinations may apply to repeat the failed subject; for repeating Category C subjects in the current academic year 2023/24 and for repeating Category A and Category B subjects in AY 2024/25 or other subsequent academic year.

#### 12. Graduation

Graduation shall be physical with graduation ceremonies to be conducted at the respective campuses as follows: 12<sup>th</sup> April 2024 Mbarara Campus, 19<sup>th</sup> April 2024 Kampala Campus and 26<sup>th</sup> April 2024 Lira Campus. The Academic Registrar will provide details regarding graduation.
